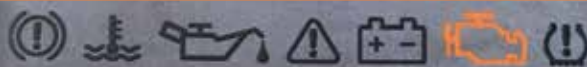

RESIDENTIAL TRASH AND RECYCLING FEES TO INCREASE IN 2023

Bridgeport Borough provides community-wide residential trash and recycling collection services through a contracted third-party provider, which is currently J.P. Mascaro & Sons (JPM). Our current contract expires at the end of 2022; therefore, Borough Council and Administration recently went through the process of advertising the contract specifications and soliciting for bids. As part of the advertising process, local trash haulers were made aware that this contract was up for bid and were encouraged to submit a proposal in order to foster competition and generate an array of providers to choose from. The Borough received inquiries from several different local trash haulers regarding the bid. However, when the deadline to submit a bid proposal passed on October 6, Bridgeport had only received a proposal from one trash hauler – the incumbent contractor JPM. The proposal from JPM includes annual pricing for the next five years – from 2023 to 2027. The JPM proposal includes an unprecedented increase starting in CY 2023 compared to what Bridgeport Borough and its ratepayers have historically been accustomed to. Our contracted cost for CY 2022 with JPM is currently \$466,116, whereas the proposed CY 2023 rate is \$745,752. This constitutes an increase of \$279,636 or a 60% increase from year to year. In order to pay for this increase in contract cost, please be aware that the **annual residential trash fee will be increased from \$320 to \$472, or from \$80 per quarter to \$118 per quarter, per household beginning January 1, 2023.** Bridgeport Borough realizes that this is a sizeable fee increase. However, there are no other viable options available to the community. Residents and ratepayers may be inclined to think that opening the Borough to a “free-market” system – where residents are permitted to select their own hauler – could result in a better rate for residents. However, there are several reasons why this would not work in our community. In speaking with other communities that have recently negotiated a new trash collection contract, they are all experiencing similar price increases, with vendors pointing to labor shortages and skyrocketing fuel, personnel, and insurance costs as the reason behind the spike in service costs. Again, Bridgeport Borough Council is sensitive to the impact this increase in contract cost will have on its residents. Bridgeport Borough always tries to keep the financial interests of our taxpayers in the highest regard – a fact that is evidenced by not having increased real estate tax millage in ten years. However, with “pass through costs” such as trash and sewer fees, ultimately these are more often influenced by external factors like the national economy and regulatory mandates. Residents should expect to receive additional information regarding the trash contract from both Bridgeport Borough and JPM as we progress closer to the beginning of 2023.

CHESTER VALLEY TRAIL UPDATE

To those who have endured the ongoing traffic and lane reconfigurations along DeKalb Street but were unsure of the nature of the project – this construction is part of the Chester Valley Trail project. The Chester Valley Trail Extension is a 3.8-mile extension that will link the existing 14.5-mile portion of the Chester Valley Trail, which currently runs from Exton to King of Prussia, to the Schuylkill River Trail in Norristown. Once complete a separate lane for bicyclists, protected by guard railing, will supplant a portion of one of the two southbound lanes that used to carry traffic from Norristown over the Schuylkill River Bridge through Bridgeport leading up to Fourth Street. Also, there has been some confusion from some who believed this to be a borough project, but please understand that this project is being conducted by Montgomery County through the trails department of the Montgomery County Planning Commission. The good news for residents and motorists is that the project appears to be nearing its end, as county officials have informed the borough that the project should be completed at some point in December 2022.

LIHWAP may be able to assist you with overdue water and wastewater bills.

What is LIHWAP?

The Low Income Household Water Assistance Program (LIHWAP) is a temporary emergency program to help low-income families pay overdue water bills. LIHWAP is a grant. You do not have to repay it.

To receive help...

- Apply starting January 4, 2022.
- You don't have to be on public assistance.
- You need to have an unpaid water bill.
- You can either rent or own your home.

How does LIHWAP work?

LIHWAP Crisis grants may be available if you have an emergency situation and are in jeopardy of losing your water service. You can receive one Crisis grant for your drinking water service and one Crisis grant for your wastewater service, up to \$2,500 each.

Crisis situations include:

- Past-due water bills.
- Termination of utility service.
- Danger of having utility service terminated (received a notice that service will be shut off within the next 60 days).

How do I apply?

- Apply online at www.compass.state.pa.us.
- Request an application by calling the Statewide Customer Service Center at 877-395-8930 or call PA Relay at 711 for the hearing impaired.
- Applications are available at your local county assistance office.

To apply, you will need:

- Names of people in your household;
- Dates of birth for all household members;
- Social Security numbers for all household members;
- Proof of income for all household members; and
- A recent water bill.

Who is eligible?

You may qualify for a LIHWAP grant if:

- You must have an overdue water bill that you are responsible for paying.
- Your household income meets the following income guidelines:

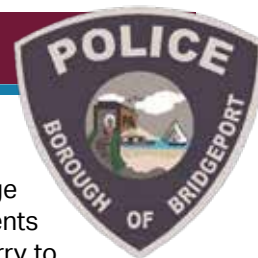

POLICE TRAINING UPDATE

The Bridgeport Borough Police Department (BPD), along with Mayor Beth Jacksier, have been extremely busy in the last six months. In response to the need for additional emergency service trained personnel, we began the training process for Water Rescue Safety Technician certification for five police officers. This will complement the seventeen members of the Bridgeport Fire Department that are awaiting the final stage of training with riverine boat operations. Training for active shooter scenarios is ongoing with the assistance of Montgomery County SWAT. This would enable our officers, from disparate agencies, to work together if the need arose.

BPD EMBARKS ON HIRING PROCESS, PLANS FOR RETIREMENT OF VETERAN OFFICER

BPD, through the Bridgeport Civil Service Commission, has initiated a full-time patrol officer hiring process. Eleven candidates applied; ten of which participated in the written test and physical agility examinations. From that pool we had six candidates advance to the oral boards in September. The borough expects to select a final candidate in October or November.

This hiring process is part of the planning process in relation to the imminent retirement of long-time officer, John Pizza. Pizza, a Bridgeport native, began with BPD in 1989. During his years of service, he coordinated community relations events and juvenile justice programs as our Juvenile Officer, among many other

accomplishments. For all that know Officer Pizza, he has served with integrity and is a wealth of institutional knowledge that allowed for all of Bridgeport's residents to be just that much safer. We will be sorry to see John leave in early 2023 but wish him the best!

Bridgeport's newest part-time officer, Justin Broskey, 27, of Warrington, PA, was sworn in on September 13. Justin is a certified EMT and has worked in hospital settings as a medical professional. Broskey enjoys serving as a Warrington Fire Company fire fighter, the beach and physical fitness.

Parks and Recreation

In late September, construction began on the Memorial Park Trail project. This project consists of two parts. First is the installation of new curb and sidewalk on the south side of Grove Street, at the foot of Memorial Park, from Union Avenue to the Bridgeport Memorial Park parking lot at the corner of Grove Street and 9th Street. A painted crosswalk will also run from the sidewalk along the front of the park's parking lot and connect to the walking path at Bridgeport Elementary. Secondly, this project also includes the construction of a meandering walking trail along the hill connecting the new Grove Street sidewalk to the existing track atop Bridgeport Memorial Park. This project was funded predominantly by a Montco 2040 grant award in the amount of \$192,800, and completion of this project is estimated to take place in early November. This project provides several benefits to the borough residents. The new sidewalk allows students and parents to safely walk on both sides of Grove Street, to and from both Memorial Park and Bridgeport Elementary. The walking trail provides a new fun and challenging path up the hill of Memorial Park, along with benches located on the path to sit and enjoy one of the most scenic views in the county. The new curb will reduce the flow of stormwater that runs down the hill and across Grove Street and will keep the majority of that flow running along the curb line until it is collected by inlets closer to Union Avenue. Additionally, this project also involved the removal of several dead tree stumps as well as an asphalt pad that was once home to a bandstand, bringing a better cosmetic to the hillside.



While the Borough believes that the public will enjoy this new amenity once complete, it understands that there have been questions raised as to the width of the sidewalk and narrowing of Grove Street. Please understand that maintaining as wide a travel width as possible was also one of the Borough's primary goals with this project. Careful consideration and review went into this design. The total width of Grove Street with the new sidewalk installation is 26 feet. This means that after deducting 8 feet in width for street parking, the remaining drivable width of Grove Street will now be 18 feet. For context, a standard bus is 8 feet wide, similar to a super duty pickup truck. Further, the average width of a regular car is 5.8 feet, and a truck is generally 6.7 feet wide according to the Federal Highway Administration website. So, with a street width of 18 feet, and a possibility of a vehicle anywhere from 5.8 to 8 feet in width, more often than not there should be no problems with two vehicles passing on Grove Street. Another concern for the Borough was to not cut so far into the hillside that any tree roots would be harmed potentially leading to their death. The wooded hillside of Memorial Park is a beautiful feature in our community that we wish to accentuate; thus, preserving the pines and oaks that grow along the side of Grove Street was very important. Bridgeport Borough is excited to unveil the Memorial Park Trail project when it is finally completed and welcomes residents to visit and enjoy this new amenity.

Public Works

The Public Works Department consists of four full time employees. While few in number, our Public Works staff are incredibly dedicated to their work and pride themselves on delivering as high a quality of life to our residents as possible. The routine maintenance activities of the Public Works Department include landscaping, fleet maintenance, snow removal, minor road repairs, physical plant maintenance, traffic signal maintenance, street sweeping and street signs. The Public Works Department also plays a vital role in Bridgeport's community events operations, such as plotting detours for the annual 5K Run, decorating the town with "Season's Greetings" lights and community banners, and erecting the Christmas Tree at Borough Hall. 2022 PAVING SCHEDULE ANNOUNCED

Bridgeport Borough would like to announce that at the October 11 meeting of Borough Council, the 2022 street paving project contract was awarded to Allan Myers LP of Worcester. The total contract cost for this project is \$710,450. Borough officials are proud to be able to say that since 2016, nearly 90% of borough streets have been repaved; all of which has been achieved without taking on additional loan debt or increasing borough property taxes. Due to COVID and other urgent town matters, no paving projects were conducted in 2020 or 2021. However, the borough still used that opportunity to apply for grant funding and obtain monies for future paving projects. In fact, a total of \$413,000 in block grant awards will help offset the overall cost of the 2022 street paving project. The milling of borough streets should begin sometime in mid-November, weather permitting. However, in the event that colder weather sets in too soon, please note that the entire project may be delayed until Spring 2023. Please understand that if your street is listed below, you will be seeing "no parking"

signage posted on your street during the days that your street is scheduled for restoration. However, our contractors are made aware that we expect at least 48 hours' notice given to residents prior to having to move their vehicles. The Borough wishes to announce that the 2022 borough-wide paving project specifications include the full-width restoration of the following street and alley segments:

Prospect Street, 4th to Fraley
Merion Street, 5th to 9th
Rambo Street, Ford to Mill
Vine Street, 4th to Front

Mill Street, between Rambo and 5th
5th Street, between Green and DeKalb
9th Street, between Mill and Green

Recycling Roundup

To all Bridgeport Residents and Businesses:

Bridgeport Borough Recycling Ordinance #2018-004, requires the following:

1. All residents and businesses must separate recyclables, including glass, plastics #1, 2, 3, and 5, aluminum and bimetallic cans, paper, and cardboard, from their solid waste.
2. All residents and businesses must separate leaf waste, including leaves from trees, bushes, and other plants, garden residue, chipped shrubbery and tree trimmings, but not including grass clippings, from their solid waste, and either compost leaf waste on their property, set leaves out during municipal leaf pickup days (please view the Yard Waste Collection page for annual dates),

self-haul the leaf waste to a state-approved composting facility (such as the Heuser Park Compost Site in Upper Merion Township) or have a hauler collect the leaf waste, to be delivered to a state-approved composting facility.

3. All residents and businesses are prohibited from burning recyclables and leaf waste or including these items with their other solid waste (trash).

Single-stream recycling allows Bridgeport Borough residents to place all recyclables: cans, bottles and plastics together with newspapers, cardboard, etc. in one container. There is no need to separate items since the "single stream" recycling process used allows all recyclables to be mixed together.

How do I separate Trash from Recycling?

It is easiest to have a container or two set up where it happens,

like a bin in the kitchen for bottles and cans you have washed out, and another in the office for used paper and mail. Just remember that with single stream recycling, it can all go in the same container – we do the sorting for you. Single stream recycling will be collected by a compaction truck. Only recyclables will be on this truck on your recycling day, it cannot collect non-recyclable items.

Acceptable Recycling Materials

Metal: Aluminum cans, aluminum foil and foil plates, etc. Metal lids, Metal food cans (tin/steel).

Glass: Glass bottles and jars (food and drink only, any color). Please rinse all food waste from bottles and cans before recycling.

Plastic Containers: Plastic bottles and containers labeled #1 through #7 (soda, water, milk, juice, liquor, shampoo, detergent, condiments, salad dressing, yogurt, margarine).

Mixed Paper and Cardboard: Newspaper and inserts, magazines and catalogs, junk mail, envelopes, file folders, white/colored/computer paper (staples and paper clips ok), corrugated cardboard, paper bags, phone books, wrapping paper (remove metallic paper and bows). Please remember to flatten all cardboard/paper boxes and containers.

Unacceptable Recycling Materials

Ceramics, dishes, coffee cups, drinking glasses, glass oven ware, Pyrex, window glass, mirrors, light bulbs, plastics without #1 - #7 labeling, plastic bags, styrofoam, bubble wrap, tissue or paper towels, wax paper cartons, metallic or coated paper, waxed boxes, and food contaminated cardboard (i.e. pizza boxes).

E-Waste Alert! Disposal Ban

Solid waste disposal facilities in Pennsylvania are no longer allowed to accept televisions and computer devices including hard drives, monitors, keyboards, mice and printers or their components. Retailers such as Staples® and Best Buy® often have e-waste recycling options at no charge. Check their websites, restrictions may apply.

Use Retrievr for your Electronic Waste Recycling Needs!

Montgomery County has recently partnered with RETRIEVR to provide local electronic waste recycling services. For a small fee, Retrievr will take just about any clean and dry textile or fabric in your home, and most electronic devices or accessories including TVs, computers, monitors, and mobile phones. For more information, contact Retrievr.com or text "PICKUP" to or call 757-703-3824.

Please note that we do not take household appliances, such as dishwashers, refrigerators, toasters, vacuums, hair dryers and the like. Please see our Greater Philadelphia Area page for the full list of accepted items.

Disposal of Household Paints

Latex paint: Let paint dry in can. Adding kitty litter or a commercial drying agent will speed up the drying process. When paint is dry, double bag the can before putting it in the trash. Leaking paint will damage our trucks and stain your street. **Oil based paint:** Is hazardous waste and will not be collected. Call Montgomery County Recycling (610-278-3618) for drop off locations and dates.

Bridgeport Borough Blue Recycling Containers

Blue Borough containers are for recycling collection use only. Remember: If you move, the blue container should be left behind at the household as they are the property of Bridgeport Borough. If you need a replacement, call the Borough Offices at (610) 272-1811.

Bridgeport Borough Fall Leaf Collection

Bridgeport Borough Public Works performs residential fall leaf collection every year in November. The 2022 fall leaf collection schedule will be every Monday and Friday during the month of November. Please gather leaves along the curb line of your property, unbagged. Public Works will remove them from the curb line of your property during their normal daytime hours of operation.

Heuser Park Composting Site in Upper Merion Township

All Bridgeport residents are permitted to use the composting site at Heuser Park in Upper Merion, 694 W. Beidler Road for disposal of residential yard waste. A couple notes to be aware of before going:

1. You must bring photo ID to verify that you are a Bridgeport resident. Only Upper Merion and Bridgeport residents are permitted to utilize this free service.

2. This service is for residential yard waste only. Commercial landscapers will be denied access.
3. You must have grass clippings separated from tree and bush trimmings, but you may bring both. There are two separate dumping locations for each of these within the site - please tell the attendant what you have and they'll direct you where to dump each.
4. You must check in at the weigh scale shed as you enter the park, and drive over the weigh scales before entering the composting site. All vehicles are weighed before and after dumping to accurately gather tonnage data.
5. No dirt, rocks or mud, thus no sod as well. If you have large root balls that you are discarding, you must hose/knock off as much dirt from between the roots as possible before dumping. Dirt and rocks damage the grinder used to process the yard waste.

Please feel free to take advantage of this free service available to all Borough residents. THE TYPICAL ESTATE PLAN

When contemplating an estate plan, there are typically, at least, three (3) documents recommended. The first document is the Last Will and Testament (the "Will"). The Will sets forth several important decisions in the event of your passing. You must select an Executor/Executrix, as well as an alternate. This position is commonly someone you trust and who is organized. It is often a spouse, an adult child, or a trusted friend. In Pennsylvania, the attorney for the estate will do most of the work in probating the estate. In my office, we handle most of the responsibilities. However, we do not allow ourselves access to estate funds. Rather, we advise the Executor/Executrix as to who should be paid and the amount.

If there are children involved, you may want their shares, as beneficiaries, to be held in Trust until they reach a certain age, typically 18, 21, 25 or any age preferred. You would be required to select a Trustee, who has a fiduciary obligation to the beneficiaries of the Trust. The Trustee must use his/her best efforts to safely manage the assets of the Trust.

If there are minor children, you would also designate a Guardian of the minor children. The Guardian is the individual who has the responsibility for the day-to-day physical care of your child, in the event of your passing. This person can be the same as the Trustee, or it can be someone completely different. There are pros and cons to each choice.

The primary purpose of your Will is to distribute your assets to your beneficiaries and see that your wishes are honored. This can be very simple, or it can be complicated.

The second document recommended is a Power of Attorney (POA). Your Will only become legally binding after you pass away. However, there are often times when you cannot conduct your own affairs, but fortunately, you are still with us. This can be due to an illness, general physical condition, or an accident. The POA designates the person to conduct your affairs during this period. The POA is extinguished, or is no longer effective, the minute you should die. The Executor/Executrix would then take over upon opening the estate.

The final document is called a Living Will (LW). Although this may sound harsh, it is the "pull the plug" document. It speaks to situations when you are still alive, but two (2) physicians agree that they have done all they can for you and that there is virtually no chance of recovery. You should NOT sign a hospital's version of a LW, unless it is reviewed by a professional. You will likely be asked by the representative of the hospital if you have a LW prior to surgery or an extended hospital stay. Most of my clients sign a LW, while some have personal or religious objections.

Our best advice is that you have considered all three (3) of these documents as part of a typical estate plan. The process is painless, affordable and will foreclose most of the common problems of estate administration.

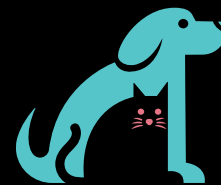
