Every year, Bridgeport Borough provides a \$2,000 scholarship to a worthy student through the Vincent Miraglia Scholarship. The scholarship is named after Dr. Vincent Miraglia, long time health officer for the borough and principal of the former Bridgeport High School. The scholarship is open to all Bridgeport residents who are high school graduates and have lived in Bridgeport for at least 2 years prior to April 1, 2019, who are seeking further education that will result in degree, diploma, or certificate. 2019 applications will be sent to Upper Merion High School and local parochial schools in early April, with a decision rendered in May. NEW BOROUGH SPEAKER SERIES FOCUSES ON MENTAL HEALTH CONCERNS

On January 24, Bridgeport Borough hosted its first in a series of quarterly speaker engagements focused on shedding more light on mental health concerns, as well as ways to address them. Bridgeport welcomed Jordan Burnham as its first speaker; Jordan is an Upper Merion graduate and a suicide attempt survivor who now speaks publicly in an attempt to remove the stigma surrounding topics like suicide and depression. The event was received extremely well, with over 40 attendees turning out to fill borough hall. We hope to see the same interest in our next speaker event - scheduled for April 3rd. This session will provide QPR training to those who attend. QPR, or (Question, Persuade, and Refer", is a method of training designed to help concerned friends and family identify symptoms of suicidal thoughts and prevent loved ones from making the attempt. FINAL DESIGN OF TOWN CENTER PARKING LOT APPROVED; CONSTRUCTION TO BEGIN IN SPRING

At the February 12 meeting of Bridgeport Borough Council, the final design for the Town Center Parking Lot & Civic Event Area was unveiled and approved. This project was awarded \$196,000 in funding through Montgomery County's 2040 grant program, making Bridgeport the recipient of the largest grant award in 2018. This project will see the construction of a municipal lot on the property surrounding borough hall at 63 West 4th Street. This parking lot would also serve as a community gathering place and site for the many events hosted by Bridgeport Borough. Now that the final design has been approved, Bridgeport must submit the plans to the County for their approval, prior to putting the project out to bid. Bridgeport staff aims to begin construction in early spring and intends to have the project completed prior to the Bridgeport Carnival in June.

TWO NEW COMMITTEES WANT YOUR INPUT!

Bridgeport has created two new committees, both of which encourage public attendance and opinion – the Community Events Committee and the Sustainability Committee. The Community Events Committee helps to coordinate our great events and also brainstorms ideas for new events; while the Sustainability Committee focuses on a vision for a clean renewable energy future and other green initiatives that could be implemented in Bridgeport. Below are the 2019 meeting dates for each.

BRIDGEPORT ENACTS INCREASE IN SEWER RATES

Beginning the first quarter of 2019, Bridgeport Borough residents and businesses will experience slight increases in their sewer usage rates. Below, please find the full schedule of increases:

- 1. The residential fixed rate of \$36 (which covers the first 6,000 gallons of usage each quarter) has been raised to \$45.
- 2. The commercial fixed rate of \$80 (which covers the first 6,000 gallons of usage each quarter) has been raised to \$90.
- 🚰 3. The minimum usage threshold will remain at 6,000 gallons.
 - The charge for usage over the 6,000 gallon minimum has been raised from \$1.38 per 100 gallons to \$1.45 per 100 gallons.

Please understand that the borough does not take rate mincreases lightly. However, when developing the 2019 budget for the Bridgeport Sewer Fund, a deficit was projected that could not be solved through further cuts in spending. The Sewer Fund faced a similar deficit in 2012, which ultimately led to a large sewer rate increase that year. In 2012, a two-step rate increase proposal was presented to the borough; Step one would allow the borough to balance the 2012 budget, but Step 2 would have allowed for greater Ilexibility by providing additional revenue the borough needed to undertake massive improvements necessary at the sewer plant. At the time, the borough opted to only adopt Step 1, as this alone resulted in substantial rate increases to gresidents and business owners and Step 2 was seen as being too much to pass onto residents at one time. The borough was able to provide a balanced budget and deliver a high quality of service from this sewer rate increase for six years, from 2012 to 2018. However, every year since 2012, costs continue to increase while revenues have remained meutral. In order for the borough to continue operating its wown sewer treatment facilities, and to responsibly budget for needed repairs and improvements to the system, this increase was necessary. In terms of overall impact to individual account holders, residents with average water usage should expect increases in their quarterly bills in the grange of 10 to 13 percent. For example, an average household that uses 12,000 gallons of water per month will see their sewer bill increase from \$118.80 to \$132.00; an pincrease of \$13.20 or about 11%. We thank you for your cooperation and understanding, and we will continue to strive to deliver the best service possible.

INCREASED BOROUGH TRAFFIC ENFORCEMENT AND POTENTIAL CONSEQUENCES

The enjoyable spring and summer seasons will be upon us soon. To insure and maintain safety for all borough residents, traffic enforcement within the borough will be

increased. The beautiful weather brings people outdoors and there is a significant increase in pedestrians, runners, and playful children. For these reasons, it is vitally important to follow all speed restrictions, obey traffic controls signals, keep an eye out for pedestrians in the street, and most importantly, DO NOT TEXT or SEARCH THE INTERNET and DRIVE! With the increased traffic enforcement comes an increased risk of residents receiving traffic citations and the attendant consequences. The common consequence of a traffic citation is the payment of a fine. However, certain citations may bring with them license "points" or suspension, which may also lead to an increase in insurance rates. Common offenses with "points" include the following:

Red Light Violation

Improper Passing

3 points

School Zone 3 points; 60-day suspension for 2nd offense

The accumulation of points may lead to a license suspension or require retaking and passing the driver's license exam. With the nice weather bringing residents outside, the biggest fear is a pedestrian or child being injured by a car. If you find yourself in the horrific situation of impacting someone with your vehicle, while the fear and anxiety involved may lead you to just want to drive away, that would be the worst decision you can make. Most accidents with pedestrians are that, "accidents." Situations for which you have car insurance and will not involve any criminal charges. Even if the situation is an accident, once you flee it then becomes a crime. Therefore, always stop in the situation of an accident with a pedestrian, or another vehicle, to help, render aid, or call for a first responder and provide the proper information to the police for insurance purposes.
