#### **MUNICIPAL PARKING LOT COMING IN 2019!**

Earlier in 2018, Montgomery County named this year's group of 2040 Grant award winners. Bridgeport was awarded \$196,000 for its proposed project, the Bridgeport Town Center Parking Lot & Civic Event Area; more funding than any other municipality received in 2018. This project entails the construction of a municipal parking lot on the property surrounding borough hall at 63 West 4th Street, which would also serve as a community gathering place and site for the many events hosted by Bridgeport Borough. Having a centrally located municipal parking lot should greatly benefit the many businesses in our downtown area that currently suffer from a lack of parking. and hopefully attract new businesses that will see Bridgeport as a new opportunity. Additionally, it will accentuate how walkable Bridgeport is, and give residents an attractive venue to gather and enjoy community events. Final designs for the project are currently being drafted, and Bridgeport hopes to break ground in early Spring 2019.



# MESSAGES FROM PUBLIC WORKS

Leaf Collection 2018: Fall has certainly arrived, and with it the borough's leaf collection will commence. Street side leaf collection is performed by the public works department. Please place piles of leaves neatly along your curbside. Below are the remaining 2018 dates where the borough public works department will conduct curbside leaf pickups:

# Monday, November 26 Friday, November 30

Leaves must be ready by 7:00am in order to be picked up on each respective day. Thank you for your time!

Winter Driving Tips: Public Works always strives to remove snow from the streets as quickly and safely as possible after a storm, and offers the following suggestions to ensure safe winter driving:

- 1. Try not to drive during a storm.
- If you must drive, leave plenty of time for your travel, and leave extra space between vehicles to maintain a safe driving distance.
- 3. Give plows and snow removal equipment the right of way. Do not pass plowing equipment if active.

Snow Removal and Borough Streets: Please be aware, if you begin shoveling your walks and driveways before plowing has ceased, your driveway aprons may be plowed in. The Borough has no ability to eliminate this occurrence, however we do take every effort minimize this event. We also employ efforts not to cause windrows over sidewalks.

Throwing, shoveling and plowing snow from sidewalks or driveways into the street is strictly prohibited.

A twelve-inch path must be cleared on your sidewalk twelve hours after a storm has ceased. Friendly tip: It is much easier to clear your sidewalk path as soon as possible. Waiting too long could allow ice to form and make shoveling both difficult and hazardous to your health.

If your first strenuous physical activity of the year would be shoveling snow, think about having someone to do it for you.

# PARKING DURING SNOW EVENTS

Our first noteworthy snowstorm came extremely early this year. As such, the Borough would like to remind residents of some important points when it comes to parking in town and snowstorms:

- 1. Saving spots: In a small, densely-packed town like ours, it is only natural to feel some ownership of onstreet parking, especially when you just shoveled that space out! However, residents are not permitted to place cones, chairs, or any other items in the street as a method of "saving a parking space." All on-street parking is public parking and thereby open and available to any vehicle.
- 2. Public Works: Once the public works crew has been able to successfully clear all of the borough streets and alleys of snow, they will also try to accommodate residents by clearing on-street parking areas. That is not to say that public works will be able to address every portion of on-street parking during every storm. However, if you are able to coordinate amongst your neighbors and clear the cars from your block, then try to flag down a passing borough plow driver and they should be able to help clear your block!

# BRIDGEPORT BUSINESSES REQUIRED TO RECYCLE IN 2019

Earlier in 2018, Bridgeport Borough adopted Recycling Ordinance 2018-004, requiring:

- All residents and businesses must separate recyclables including glass, plastics #1, 2, 3, and 5, aluminum and bimetallic cans, paper, and cardboard, from their solid waste.
- 2. All residents and businesses must separate leaf waste, including leaves from trees, bushes, and other plants, garden residue, chipped shrubbery and tree trimmings, but not including grass clippings, from their solid waste, and either compost leaf waste on their property, set leaves out during municipal leaf pickup days, self-haul the leaf waste to a state-approved composting facility (such as the Heuser Park Compost Site in Upper Merion Township) or have a hauler collect the leaf waste, to be delivered to a state-approved composting facility.
- 3. All residents and businesses are prohibited from burning, recyclables and leaf waste or including these items with their other solid waste (trash).

BUSINESSES AND LANDLORDS: Effective January 1, 2019, businesses and apartments with four or more units are required to contract with a hauler for the collection of the listed recyclable materials and leaves. Bridgeport is committed to aiding businesses and landlords with this transition.
