SITE WORK BEGINS ON FORMER CONTINENTAL BUSINESS CENTER SITE

Residents may have noticed that over the past few weeks, the riverfront property that was once home to the Continental Business Center has undergone a cosmetic transformation. In recent months a developer, PRDC Properties, has obtained equitable interest in the 30+ acre, multiple-parcel site that has been abandoned since a catastrophic fire gutted the massive industrial complex in 2001. In fact, May 15, 2020 marked the 19-year anniversary of the fire; and though thankfully no lives were lost, the landscape of the town was drastically changed by the loss of this economic engine and employment hub. While the potential redevelopment of this abandoned property is an exciting notion, Bridgeport Borough also understands that many questions naturally arise from the proposition as well. In order to be as transparent as possible with residents, the borough wishes to provide the following information for public consumption.

What is being proposed in this development project?

This project has not received any formal approvals from the borough at this time. However we do know that the developer wishes to build something very similar to the project that O'Neill Property Group, the previous owner of the land, had received approval to build several years ago, based on the sketch plan presentation that PRDC gave to Borough Council during a January 28 public meeting. The sketch plan proposed a townhome development consisting of around 325 units; a 250-unit apartment building; and a mixed-use building that would consist of commercial space on the ground floor and dozen condominiums above. Again, PRDC has not received approvals for subdivision, land development, zoning or building permits at this time; meaning that despite what has been proposed initially, the plans are in their early stages and still subject to change.

Where is this project in the land development approval process? This project is in the extremely early phases of design, planning and approvals. At the January 28 meeting of Borough Council, PRDC made a sketch plan presentation of their vision for the property. While Council received the sketch plan favorably, please understand that no official approvals were given to PRDC at this meeting. The borough has yet to receive fully engineered plans for this project, meaning that PRDC has several more steps to complete before development can begin.

If the developer has not received any approvals yet, then why are they performing work on the site already? And what exactly are they doing down there? PRDC is performing the early phases of the site work that would be necessary regardless of who ultimately develops the land. Namely, PRDC is 1) clearing the property of vegetation and debris left behind by illegal dumping and 2) erecting a fence around the perimeter of the project to both protect residents and keep trespassers out. In the next few weeks, PRDC will also begin to demolish to the remaining abandoned buildings still standing on the site. PRDC, having equitable interest in the property, are permitted by law to perform this site work by obtaining the proper permits, which they have done. PRDC also intends to begin bringing in truckloads of certified clean soil in the coming months, but only after receiving the necessary permissions from the DEP and the County Conservation District. Truthfully, the fact that PRDC is willing to spend money to perform this site work before receiving any approvals from Borough Council is both a leap of faith and a gesture of good will toward the community.

Over the years. I have heard that the site might have environmental concerns. Will these be addressed prior to development? Yes. This is the former site of an industrial park that was home to multiple types of manufacturing over many years. There is a distinct possibility that there could be environmental concerns that need to be remediated before development is permitted. For example, if there is still asbestos in the old buildings, then that will be safely removed prior to demolition. If there is soil contamination, the soil may need to be excavated and removed from the site, or the soil may need to be sealed and capped within concrete. Regardless of the possible concerns, please understand that the developer, the borough, and the state environmental agencies all enter this project understanding the ramifications. Environmental studies have been performed by the current and prior developers associated with this site, and there is absolutely zero possibility of approving construction on any project without addressing these concerns in a manner approved by the state agencies that govern over the environment.

Bridgeport Borough understands that with a development of this magnitude, residents are going to have questions about the varying phases leading up to, during, and after completion. To that end, Bridgeport Borough is committed to being as receptive as possible to the concerns and

questions raised by residents throughout this process. At the same time, Bridgeport Borough also acknowledges that the approval and review process is beginning at an unprecedented time in our state and nation's history. Local governments have been required to alter the manner in which public meetings are held, as well as how the public is able to participate in these meetings. With that in mind, the borough is hopeful that we will be able to hold in-person public meetings in a safe manner again in the very near future, which will allow more immediate and responsive discourse regarding this and other topics. TWILIGHT ON THE RIVER CANCELED FOR 2020

Growing Bridgeport Together, who operates the Twilight on the River marketplace events, has regretfully determined that the 2020 schedule for Twilight on the River must be canceled. There have been discussions about weekend market dates later in the year; but much like the carnival, nothing can be scheduled until a clearer path to reopening this part of the state has been laid out.

NEW SECURITY CAMERAS FOR MEMORIAL PARK

On May 18, installation of a new security camera system began in Memorial Park. The project has a total cost of \$25,426, which was the low bid received by Valley Forge Security. \$15,000 of the project is being funded by a Keystone Communities grant. The project entails installation of a new 11-camera system that can be remotely monitored by Bridgeport Police Department, Public Works, and the Park Board. The goal is to provide enhanced security and safety for both park patrons and property.

BPD ADDS NEW VEHICLE TO FLEET

Bridgeport Police Department has obtained a new patrol car. The 2020 Ford Hybrid Police Interceptor SUV, purchased from Koch 33 Ford of Easton, was paid for entirely through a \$50,000 grant awarded by the Department of Economic and Community Development. As the first hybrid in the borough's fleet of vehicles, this patrol car is the initial step in moving towards greater use of renewable energy. The cost of upfitting the cruiser with equipment will also be covered by the same DCED grant.
